## **ABOUT UNIVERSITY**

Veer Madho Singh Bhandari Uttarakhand Technical University, Dehradun was established on 27th January 2005 by Govt. of Uttarakhand through the Uttarakhand Technical University Act 2005. The Veer Madho Singh Bhandari Uttarakhand Technical University campus is situated at NH-72 Suddhowala, Dehradun. Dehradun is the capital of Uttarakhand State and is well connected through Rail, Road and Air transport.

The University has been established in an area of 8.372 hectares and it is the only affiliating University of the state for technical institutions. There are 81 Affiliated Private Institutions and 12 Government Institutions in the University. University is running 08 UG, 06 PG and 18 PhD programmes with approximately twenty four thousand students in various courses.

**ABOUT THE FDP:** This Faculty Development Program aims to provide educators with a comprehensive understanding of recent amendments and developments in Criminal and IT laws. It endeavours to equip participants with insights into the latest changes in the legal landscape and their practical applications in teaching and research.

A certificate of participation will be given to all the participants who will be attending all sessions of the program.
