APPOINTMENT OF TEACHERS ON DEPUTATION

Veer Madho Singh Bhandari Uttarakhand Technical University, Dehradun established by Act 415/2005 of Uttarakhand State Government invites applications on the prescribed format to appoint Professor / Associate Professor on Deputation basis for short term duration (two semesters) as per terms and conditions given below.

Terms and Conditions

(B.1) Professor / Associate Professor (On Deputation)

- Appointments on deputation will be open to the individuals possessing eligibility qualification prescribed for the respective post of Professor or Associate Professor by AICTE regulations as detailed below.
- Applicants have to be in regular employment in Govt. department/PSU/ Govt. Labs/Autonomous bodies of Govt. in the scale prescribed by AICTE for respective post. However, for those organizations in which pay scales as laid down by AICTE are not applicable, the applicants in closest pay scale will be considered for the post of Associate Professor or Professor, whichever has the nearest scale as that of eligible applicant.
- Appointments on deputation will be initially for a period of 6 months (semester) which will be extended on semester basis based on satisfactory performance but it will not be for more than three consecutive years.
- Applicants for appointments on deputation have to send their applications duly forwarded from the competent authority in the parent organization/Institute/department of the applicant.
- Appointments on deputation will be entitled for pay scale and emoluments as decided by the University for the respective posts prescribed by AICTE/ PCI, New Delhi.

For Faculty of Technology

Eligibility Criteria for Associate Professor

Ph.D. degree in the relevant field and First class or equivalent at either Bachelor's or Master's level in the relevant branch

AND

At least total 6 research publications in SCI journals / UGC / AICTE approved list of journals.

AND

Minimum of 8 years of experience in teaching / research / industry out of which at least 2 years shall be Post Ph.D. experience.

Eligibility Criteria for Professor

Ph. D. degree in relevant field and First class or equivalent at either Bachelor's or Master's level in the relevant branch.

AND

Minimum of 10 years of experience in teaching / research / industry out of which at least 3 years shall be at a post equivalent to that of an Associate Professor.

AND

At least 6 research publications at the level of Associate Professor in SCI journals / UGC / AICTE approved list of journals and at least 2 successful Ph.D. guided as Supervisor / Cosupervisor till the date of eligibility of promotion.

OR

At least 10 research publications at the level of Associate Professor in SCI journals / UGC / AICTE approved list of journals till the date of eligibility of promotion.

For Faculty of Pharmacy

Eligibility Criteria for Associate Professor

First Class B.Pharm with Master's degree in Pharmacy (M.Pharm) in appropriate branch of specialization in Pharmacy (Qualification must be PCI recognized). A PCI recognized Pharm.D degree holder shall also be eligible for the posts of Associate Professor in the subjects of pathophysiology, pharmacology and pharmacy practice Associate Professor shall acquire PCI recognized Ph.D in any of Pharmacy subjects within 7 years to become eligible for the post of Professor.

And

3 years experience in teaching or research at the level of Assistant Professor or equivalent in PCI approved/recognized Pharmacy College.

Eligibility Criteria for Professor

First Class B.Pharm with Master's degree in Pharmacy (M.Pharm) in appropriate branch of specialization in Pharmacy or Pharm.D (Qualifications must be PCI recognized) With Ph.D degree in any of Pharmacy subjects (Ph.D. Qualifications must be PCI recognized).

And

10 years experience in teaching in PCI approved/ recognized Pharmacy College or research experience out of which 5 years must be as Associate Professor in PCI approved/recognized Pharmacy College.

(B.2) General Instructions:-

- (i) Unsigned/Incomplete application or without supporting documents, and application received late shall be summarily rejected.
- (ii) The number of vacancies may be increased or decreased. The University reserves the right to fill or not to fill the post(s).
- (iii) Merely fulfilling the minimum qualification does not mean that the candidate will be called for interview, if any.
- (iv) The candidate has to appear for Interview in physical mode only. In case, if the candidate is selected, he/she have to submit joining of duties physically to the Registrar VMSBUTU or as directed in the offer letter.
- (v) Candidate has to make sure that they are fully eligible for any particular post they are applying for, and the original certificate/documents in support of information furnished in the application form are to be provided at a later stage of recruitment process at the time of interview only. **No deviation, whatsoever, from the filled-in details will be entertained in any circumstances.**
- (vi) Candidate is advised to write the desired information carefully in the application form. University will not be responsible for the loss due to wrong/deficient information filled in the application form. No change/deviation will be entertained.
- (vii) The University reserves the right to place a reasonable limit on the number of candidates to be called for selection process based on higher parameters over and above the essential qualification.

- (viii) All communications to the candidate will be send through e-mail / notification on website only. No other mode of communication will be adopted, so before sending the application form, candidates are required to have at least one working e-mail which should be correctly mentioned as it will be only be used.
- (ix) No TA/DA will be paid for appearing interview, if any and joining the duties.
- (x) University will not be responsible for any technical delay.
- (xi) Interim correspondence/enquires shall not be entertained or replied to.
- (xii) Any attempt to influence the recruitment process whatsoever will lead to disqualification of candidate
- (xiii) In case of any dispute the decision of the Vice-Chancellor, VMSBUTU shall be final and binding.
- (xiv) The applicant(s) must be carry the original photo I.D. proof (which has been indicated by him/her in the application), at the time of Interview, if any & joining for verification.
- (xv) The applicant(s) shall have to produce necessarily in original testimonials at the time of interview, if any falling which the applicant(s) will not be allowed to appear in the interview.
- (xvi) The selected candidate(s) will not be allowed to accept or hold any other full time /part time assignment in online/offline mode during the period of holding his/her position in the VMSBUTU.
- (xvii) The Selected candidate(s) shall have no legal right to claim regularization or absorption against any post or extension of tenure or any further engagement agreement at the VMSBUTU. On or after termination of the tenure of short-term appointment, he/she will not have any right to seek permanent absorption in University or its Campus Institutions.
- (xviii) All applicants who are presently employed in Government/Semi Govt./Public Sector Undertaking/ University/Recognized Educational Institute etc. should apply through proper channel from the organization along with a self-declaration stating no Vigilance or Disciplinary action/enquiry is pending or contemplated against them and also submit a no objection certificate from present employer. Failure to provide the same shall make them ineligible for consideration to the post. Application received late shall not be entertained and delay in transit shall be the responsibility of applicant.
- (xix) The educational qualification, age, experience and other conditions of eligibility as stipulated above against the post shall be determined as on the closing date of receipt of applications.
- (xx) Application forms must also be accompanied by attested copies of all Educational and Professional Qualification, Experience Certificate, Category Certificate, etc. An application, without the said documents is likely to be rejected during the course of screening.
- (xxi) All appointments shall be purely temporary in self-finance mode for short term and can be terminated any time by the University with or without assigning reasons.
- (xxii) Employment in the University shall be governed by the rules and regulations, service conditions specified in the Act. /Regulations/Orders of the University as may be notified from time to time.
- (xxiii) No documents may be accepted or considered by the University after submission of application form by the candidate and no subsequent request for its change will be considered.
- (xxiv) Candidature of applicant shall be subjected to verification of testimonials at a subsequent stage.
- (xxv) Candidate should not have been convicted by any Court of Law.
