Sub: Very Important: Seeking Urgent Intervention to ensure that existing Technical institutions take MANDATORY AICTE Approval for Academics Year 2024-25 for admitting students

Warm greetings from the All India Council for Technical Education...!

As you may be aware, obtaining AICTE approval is imperative for all Technical Institutions, including Deemed Universities, to facilitate student admissions for the forthcoming Academic Year 2024-25. We have noted that certain institutions within your state have failed to meet this critical deadline and omitted to apply for an Extension of Approval, this oversight could result in their exclusion from the state's admission seat matrix. However, the Council is fully equipped to assist in reopening the portal for Government Institutions to apply for an Extension of Approval for the Academic Year 2024-25, albeit with the required penalty.

Considering these circumstances, the Council sincerely requests your immediate intervention to ensure that non-compliant institutions promptly initiate the Approval process with AICTE, including the payment of Late Fees. It is imperative to note that, as per the directives of the Hon'ble Supreme Court of India, AICTE is obligated to finalize the entire approval process by the 30th of April, 2024.
