Temporary appointment as Assistant Professor (Short Term Engagement) for period of 11 months in Campus Institutions of Veer Madho Singh Bhandari Uttarakhand Technical University, Dehradun (VMSBUTU) on self-financed basis

On the recommendation of the Selection Committee meetings held during 24th August 2023 to 29th August 2023, the Hon'ble Vice Chancellor of the University is pleased to approve the engagement of following candidates as Assistant Professor (Short Term Engagement) on temporary and self-financed basis for a short term period of 11 months with effect from the date of joining the place of duty (Campus Institution) detailed against each candidate on the terms and conditions mentioned herein. Terms and Conditions of the Assistant Professor (Short Term Engagement) for period of 11 months

1. The "Assistant Professor (Short term Engagement)" shall be engaged for Academic Session 2023-24 only for a duration of maximum 11 (eleven) months only.
2. The candidate must possess qualifications as per applicable norms prescribed by the concerned regulatory bodies, AICTE/UGC as applicable failing which it will be cancelled at any stage by the University, whenever it comes to the notice.
3. "Assistant Professor (Short term Engagement)" shall perform all duties assigned by the University and the Campus Institution where deployed. They have to ensure, completion of academic examination processes for all type of examinations (Regular/Back paper/ Special back paper etc.) for the courses allocated to them even if the tenure of engagement is complete.
4. "Assistant Professor (Short term Engagement)" will be entitled to avail causal leave of 15(fifteen) days only in full tenure of 11 months engagement.
5. "Assistant Professor (Short term Engagement)" will be entitled availing "academic leave" for the period of 05(five) days only, its maximum in the entire duration of engagement for participation in academic events training programs, workshops, conference, etc.
6. Selected Candidate may bring any type of project from Govt./Corporate Funding Agency and required resources/facilities on the conditions laid down by the University from time to time for the duration of engagement.
7. The posts are purely temporary and the selection shall not confer on the appointee any right of permanent appointment/regularization or for payment of other allowances and/or benefits admissible to regular faculty. No claims and correspondence in this regard will be entertained at any stage.
8. The "Assistant Professor (Short term Engagement)" will be a full time employee for the entire 11 months period of engagement and he/she is required to adhere to the administrative and disciplinary regulations of the VMSBUTU/Government. Failure to comply with the same will be a ground for termination of the "Assistant Professor (Short term Engagement)" without notice any time during the period of engagement.

9. The working hours/days for the Assistant Professor (Short term Engagement) will be as notified by the University/Institution as applicable. No extra benefit will be allowed for working beyond the office hours. Unauthorized absence from the work/work place for a continuous period of 06 days without valid reasons shall lead to automatic termination of the engagement. Regular attendance of the Assistant Professor (Short term Engagement) will be ensured by the Director/Officiating Director of the Institute.
10. Selected candidate(s) will not be allowed to accept or hold any other full time /part time assignment in online/offline mode during the period of his/her position of Assistant Professor (Short term Engagement) in the Campus Institutions of VMSBUTU.
11. If the selected candidate(s) leaves the engagement without permission, he/she shall not be provided "Certificate of Experience", and not be paid any emoluments/amount due to him/her on that day. The working candidates have to submit "No dues Certificate" to the Director of the Campus Institute /Registrar of VMSBUTU. The decision of the competent authority in this regard shall be final.
12. In the event of his/her leaving the engagement under unforeseen situations, the Assistant Professor (Short term Engagement) will be required to submit at least one month prior notice for acceptance of his/her resignation. Otherwise, the Competent Authority has right to forfeit his/her emoluments. However, his/her service will be terminated at any stage/time, if he/she is found guilty in any type of misconduct or his/her performance is not found up to the mark. Concealing of facts or canvassing on any matter in any form shall lead to termination at any time/stage.
13. The Selected candidate(s) shall have no legal right to claim regularization or absorption against any post or extension of tenure or any further engagement agreement at the Campus Institutions of the VMSBUTU, on or after termination of the 11 months tenure of Short term Engagement, he/she will not have any right to seek permanent absorption in the University or its Campus Institutions.
14. Employment of the University shall be governed by the rules and regulations, service conditions specified in the Act/Regulations/Orders of the Campus Institute / University as may be notified from time to time.
