#### f) Grievance Redressal Mechanism

It was decided to introduce a QR code of every registered student which should be generated based on their details available on University Management System. This will help in quick access of the information about any student for verification and other academic purpose. This QR code may be used in the their admit cards/verification and identity cards.

#### i) Online Registration System in each Semester

The IQAC noted the reforms made in the form of online registration system in each semester. After deliberations, it was decided that the students who are studying in the University must be asked to compulsorily register themselves online through UMS from student login in both Odd and Even Semester before the commencement of the classes in the semester as per schedule for registration detailed in the academic calendar. This arrangement of online semester registration for newly admitted students in the academic session must be started with their provisional registration and the same should be finalized after their enrolment is confirmed. This enrollment and registration process of the 1st year student of any course should be completed during the Orientation/Induction program in the Odd Semester.

## j) Online Affiliation Portal

The IQAC noted the commencement of online affiliation portal in the University and expressed satisfaction over the action taken.

## k) Cashless Inspection Process

The IQAC noted the reforms made in the affiliation system in the form of cashless inspection process and expressed satisfaction over the action taken.
