- Ph.D degree and First Class or equivalent at either Bachelor's or Master's level in the relevant branch;
- At least two successful Ph.D guided as supervisor/Co-Supervisor and minimum 8 research publications in SCI Journals/UGC/AICTE approved list of journals;
- Minimum 15 years of experience in teaching/research/industry, out of which at least 3 years shall be at the post, equivalent to that of Professor.

In case of research experience, good academic record and books/research paper publication/IPR/Patent record shall be required as deemed fit by the expert members of the Screening & Selection Committee. If the experience in Industry is considered, the same shall be at managerial level equivalent to Professor with active participation record in devising/designing, developing, planning, executing, analysing, quality control, innovating, training, technical books/research paper publications/IPR patents etc. as deemed fit by the expert members of the Screening & Selection Committee. Flair for Management and leadership is essential.

Transfer on Deputation: -

- Must be a Professor in the Central/State Government, Public Sector Undertakings (PSUs), Govt. Universities/Institutions/Recognized Research Institutes.
