All part-time Ph.D. students who do not have absentee in two consecutive RDC meetings and who have completed six years of their registration, or seven years after taking due permission (cutoff date for determining duration being 15 July. 2020) may submit the request for re-registration on the same topic.

The application for the registration must include the following details:

- (a) Name of PhD student
- (b) Enrollment number
- (c) Subject of the Ph.D. thesis (e.g. Electrical Engg.)
- (d) The approved Ph.D. topic.
- (e) The date of registration.
- (f) All quarterly progress reports from the date of registration, duly signed by supervisor and forwarded by Principal/Director of the research centre.
- (g) The certification by the candidate and supervisor that the thesis (either doctoral or masters) has not been published on the approved Ph.D. topic (included in (d) above) elsewhere.
- (h) The clear statement that the candidate requests for the re-registration on the same topic (as in (d) above) and agrees to follow the rules of the University as are applicable from time to time (as updated).
- (i) The candidate's supervisor is eligible supervisor in UTU, as certified by the candidate, together with the information of supervisor as in annexure 1, duly signed by supervisor and Director/Principal of the institute where supervisor is currently working.
- (j) All the above details included in application duly signed and forwarded by supervisor (in(i)above) and by Director/Principal of the research centre of UTU where the candidate is registered.

All this information, duly signed and complete in all respects, must reach the UTU's Ph.D. Section by 30th June, 2020. Incomplete applications will be summarily rejected and student will fully be responsible for the consequences.
