This Memorandum of Understanding (hereinafter referred to as "MoU") is signed on day 10th of the july 2017 at Uttarakhand Technical University (UTU), Dehradun.

By & Between

Uttarakhand Technical University (UTU), Dehradun hereinaster referred to as the 'First party', of the one part.

And

The Indian Air Force (IAF) with its Headquarters at RK Puram New Delhi – 110066, under Ministry of Defence, hereinafter referred to as the 'Second Party' of the other part.

- 1. WHEREAS the **Indian Air Force** is an organization of the Govt of India and part of the defence forces of India under the Ministry of Defence, which inter-alia is also responsible for catering to the educational and training needs of all levels of personnel in Indian Air Force and committed to maintain high standards of training and education amongst all personnels.
- 2. WHEREAS, Uttarakhand Technical University, a Uttarakhand State Technical University located at Government Girls Polytechnic, post Office, Chandanwadi, Prem Nagar Suddhowala, Dehradun Uttarakhand has the primary objective to disseminate and advance the knowledge by providing instructional, research and extension facilities in such branches of learning as it may deem fit and shall endeavour to provide to students, researchers and teachers the necessary atmosphere and facilities for the promotion of
 - (a) Innovations in education leading to re-structuring of courses,
 - (b) New methods of teaching and learning and integral development of personality.
 - (c) Studies in various disciplines, including inter disciplinary studies.
 - (d) National Integration, secularism and international understanding.

3. OBJECTIVE

This MoU records mutual intent for academic collaboration between the IAF and Uttarakhand Technical University for academic progression of officers of Indian Air Force by providing opportunity to pursue Ph.D research in the areas of mutual interest. Also, it will provide opportunity to the students of Uttarakhand Technical University to undertake internship or to do project work or to use labs of IAF as per service guidelines.

4. TERMS AND CONDITIONS OF Ph.D ADMISSION

- (a) The first party has agreed to provide admission to 15 nominated officers of the second party for Ph.D programme in fields of mutual interest, and falling within the areas of Uttarakhand Technical University.
- (b) Increase or decrease of seats can be considered depending on the requirement projected by the party on second part each year.

MODIFICATION

The terms on the MoU may be modified, if and when required with the written consent of both the parties.

8. TERMINATION

Either party shall be entitled to terminate this MoU by providing the other party with three calendar months advance notice. The termination of the MoU, for whatever reasons, will not affect the rights of a party, which may have secured as at the date of termination and will further not affect any rights, which specifically or by their nature survive the termination of this MoU. However, in case of termination, officers of IAF already enrolled for any Ph.D programme as well as the students of Uttarakhand Technical University admitted into a programme shall be permitted to complete the programme.

In agreement of the above objectives, terms and conditions, this Memorandum of Understanding is hereby signed by the below mentioned parties on this 10th day of july 2017.
