MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (hereinafter MOU) is between the THDC Institute of Hydropower Engineering and Technology Tehri (hereinafter referred to as THDC-IHET Tehri), Constituent Institute of Uttarakhand Technical University Dehradun, Uttarakhand, India, and Arba Minch Institute of Technology (hereinafter referred to as AMIT Ethiopia), Arba Minch University, Arba Minch, Ethiopia constitutes a framework for cooperation between the two parties.

This MOU is developed for the purpose of facilitating exchange academic activities between the parties. THDC-IHET Tehri and AMIT Ethiopia are mutually interested in furthering collaboration on research and education.

- 1. The goals of collaboration on academic activities contained in this MOU include the following:
 - ❖ To improve international understanding of water resources of both the countries for enhanced research.
 - ❖ To increase educational and research opportunities in water resources.
 - ❖ To enrich the students and faculty exchange on research and education of both institutes.
 - To organize joint academic activities and conferences/workshops etc, and
 - ❖ To foster genuine and mutually beneficial collaboration.
- 2. The term of this MOU shall commence on the date that it is signed by both parties, and will continue in force and effect for a period of three (03) years. Thereafter it can be renewed for successive three year periods, unless either Institute terminates this agreement by giving six months written notice to the other party.
- 3. This MOU may be amended at any time by mutual written consent of the parties.
- 4. In case of disagreements between the two parties, this MOU can be cancelled by both parties by giving six months written notice prior to the date of cancellation.
- 5. Each party hereto shall bear its own expenses incurred in connection with this MOU, unless funded by some agency. Expenses, responsibilities, and other matters relating to a future exchange agreement will be negotiated on a case-by-case basis and will be memorialized in a separate written agreement. Each institution will endeavor to develop the future exchange of faculty, students, and research scholars.
- 6. The two parties should seek to promote:
 - Mobility of students for summer internship, projects and research work
 - Faculty exchange

- 8. The parties may sign an Intellectual Property Rights (IPR) document in order to secure rights when it comes to research results and publications in each individual case.
