ABOUT CONFERENCE

A constitution is the product of its particular time. Historical circumstances have a direct bearing on the formation of constitutions around the world. When the Constitution of India was being drafted, the challenge was to get out of the neo-colonial mindset. It was necessary to design the constitution in such a way that India could progress according to its resources and needs, as well as needed ideological freedom, so it did not give priority to socialism and capitalism, but to keep both together. It was decided, to accommodate India's diversity and heterogeneity, and the constitutionalists contributed to it and made sure that socio-economic diversities could be accommodated in politics. It was also necessary to make the Constitution in such a way that with the changing times, its provisions could be amended and, so the process of amendment was rationalized, so that the Constitution is able to withstand the test of time. For this reason, the amendment procedure was kept liberal so that the democratic instruments of the Constitution could be fully capable of accepting the changes. Likewise, a necessity was felt that the emerging and new constitutional ideas, which are essential in a changing society, are explained by the Supreme Court through its decisions. Therefore the task of interpretation was given to the higher judiciary. In this way, the Indian Constitution has maintained its identity as an immortal constitution.

In the changing social environment, the role of constitutional organizations has also started changing. They are required to perform new tasks, leading to many challenges, and requiring a multidimensional approach towards them. In the past decades, the formal powers of the constitutional posts were not so controversial because they used to perform formal functions. However, how far the constitutional organization of India can handle the increased functions in contemporary times is a moot question. The college has decided to take up these emerging challenges and issues through the platform of seminars to make it easier for policymakers to moderate the role of democratic constitutional organizations in the changing context.
